1. Consider the following set of data:

23 15 27 15 30

Sorted:  $\swarrow$  median  
 15, 15, 23, 27, 30  
 $\underbrace{\hspace{2cm}}$  mode

(a) Find the median.

Answer: The median is 23

(b) Find the mode.

Answer: The mode is 15

(c) Find the sample mean.

Answer:  $\bar{x} =$  22

(d) Find the sample standard deviation.

Answer:  $s =$  6.86

$$\bar{x} = \frac{\sum x}{n} = \frac{110}{5} = 22$$

$$s^2 = \frac{2608 - \frac{(110)^2}{5}}{4} = \frac{2608 - 2420}{4} = 47 \Rightarrow s = \sqrt{47} \approx 6.86$$

2. A random sample of the percentage of people in 60 different counties, that voted for a certain party in the elections is given below.

Given that the mean is  $\bar{x} = 46.15$  and the standard deviation is  $s = 8.63$ :

(a) Find a 75% Chebyshev interval about the mean for the data set above.

Chebyshev's theorem implies that 75% of the values are within two sd. from  $\bar{x}$ .  
 $[\bar{x} - 2s, \bar{x} + 2s] = [46.15 - 2 \cdot 8.63, 46.15 + 2 \cdot 8.63]$   
 $= [28.89, 63.41]$

Answer: The 75% Chebyshev interval is [28.69, 63.41]

(b) How many data values does Chebyshev's theorem predict will be within two standard deviations of the mean?

at least 75%. 75% of 60 is  $0.75 \cdot 60 = 45$  values

Answer: 45 values.

(c) How many of the data values are within two standard deviations of the mean?

Answer: 56 values.

How does this compare to your result in Part (b)?

There are more values than the minimum predicted.

3. Let the random variable  $x$  represents percentage change in neighborhood population in the last few years, and the random variable  $y$  the crime rate in the same neighborhood (measured in crimes per 1,000 people). A random sample of six neighborhoods in a city gave the following table of paired data:

$x$	29	2	11	17	7	6
$y$	173	35	132	127	69	53

Given that  $\sum x = 72$ ,  $\sum y = 589$ ,  $\sum x^2 = 1340$ ,  $\sum y^2 = 72,277$ , and  $\sum xy = 9,499$ :

- (a) Compute the coefficient of correlation  $r$ .

$$SS_{xx} = 1340 - \frac{72^2}{6} = 476$$

$$SS_{xy} = 9499 - \frac{72 \cdot 589}{6} = 2431$$

$$SS_{yy} = 72277 - \frac{(589)^2}{6} = 14456.83$$

$$r = \frac{2431}{\sqrt{476 \cdot 14456.83}} \approx \frac{2431}{2623.25} \approx 0.93$$

**Answer:**  $r =$  0.93

- (b) Find the equation of the least square line.  $\hat{y} = a + b \cdot x$

$$b = \frac{SS_{xy}}{SS_{xx}} = \frac{2431}{476} = 5.11$$

$$\bar{x} = \frac{72}{6} = 12$$

$$\bar{y} = \frac{589}{6} \approx 98.17$$

$$\begin{aligned} a &= \bar{y} - b \cdot \bar{x} \\ &\approx 98.17 - 5.11 \cdot 12 \\ &= 36.85 \end{aligned}$$

**Answer:** The equation is

$$\hat{y} = 36.85 + 5.11 \cdot x$$

- (c) Use the equation from Part (b) to estimate the crime rate for a neighborhood with 12% change in population.

Substituting  $x=12$  gives 98.17

(Notice 12 is  $\bar{x}$   
so substituting  
will give  $\bar{y}$ ).

**Answer:** The crime rate is estimated to be

98.17

4. Consider the experiment of rolling two dice. The following table lists all possible outcomes.

1 6	2 6	3 6	4 6	5 6	6 6	
1 5	2 5	3 5	4 5	5 5	6 5	
<del>1 4</del>	2 4	3 4	4 4	5 4	6 4	
<del>1 3</del>	<del>2 3</del>	3 3	4 3	5 3	6 3	$1 + 2 + 3 + 4 = 10$
<del>1 2</del>	<del>2 2</del>	<del>3 2</del>	4 2	5 2	6 2	
<del>1 1</del>	<del>2 1</del>	<del>3 1</del>	<del>4 1</del>	5 1	6 1	
1	2	4	5			

Find the probability that the sum of the outcomes of the two dice is less or equal to 5.

The possible sums less or equal to 5 are 2, 3, 4, and 5.

There are 1 outcome with sum 2  
 2 outcomes with sum 3  
 3 outcomes with sum 4  
 4 outcomes with sum 5

So there is a total of 10 favorable outcomes out of 36 possible outcomes. So  $p = \frac{10}{36} = \frac{5}{18}$  or approximately 0.28

Answer: The probability is  $\frac{5}{18} \approx 0.28$

5. In a sales effectiveness seminar, a group of sales representatives tried two approaches to selling a customer a new car. The results are summarized in the table below:

	Sale	No Sale	TOTAL
Aggressive	270	310	580
Passive	416	164	580
TOTAL	686	474	1160

Compute the following probabilities:

- (a) Find the probability that a customer selected at random bought a new car.

Out of a total of 1160 customers 686 bought a car.  
 So  $P(\text{Sale}) = \frac{686}{1160} = \frac{343}{580} \approx 0.59$

**Answer:** The probability is 0.59

- (b) Find the probability that a customer selected at random will buy a new car given that an aggressive sales approach is used.

Aggressive approach was used for 580 customers. 270 of them bought a car. So:

$$P(\text{Sale given Aggressive}) = \frac{270}{580} = \frac{27}{58} \approx 0.47$$

**Answer:** The probability is 0.47

- (c) Find the probability that a customer selected at random will buy a car **and** that an aggressive sales approach was used.

$$P(\text{Sale and Aggressive}) = \frac{270}{1160} = \frac{27}{116} \approx 0.23$$

**Answer:** The probability is 0.23

## Useful Formulae

**Mean:**  $\bar{x} = \frac{\sum x}{n}$ ,  $\mu = \frac{\sum x}{N}$

**Standard Deviation:**  $s = \sqrt{\frac{\sum x^2 - \frac{1}{n} (\sum x)^2}{n - 1}}$ ,  $\sigma = \sqrt{\frac{\sum x^2 - \frac{1}{N} (\sum x)^2}{N}}$

**Correlation coefficient:**  $r = \frac{SS_{xy}}{\sqrt{SS_{xx} \cdot SS_{yy}}}$ , where:

$$SS_{xx} = \sum x^2 - \frac{1}{n} (\sum x)^2$$

$$SS_{xy} = \sum xy - \frac{1}{n} (\sum x) (\sum y)$$

$$SS_{yy} = \sum y^2 - \frac{1}{n} (\sum y)^2$$

**Least Squares Regression Line:**  $\hat{y} = bx + a$ , where:

$$b = \frac{SS_{xy}}{SS_{xx}}, \quad a = \bar{y} - b\bar{x}$$
